

PRIVACY POLICY

WellU spółka z ograniczoną odpowiedzialnością, with its registered office in Gdynia, ul. Wielkopolska 280, 81-531 Gdynia, entered in the National Court Register managed by the District Court for Gdańsk - Północ in Gdańsk, 8th Commercial Division of the National Court Register under number KRS 0000354591, NIP (Tax ID) number: 586-225-16-36 REGON 220970076 with a share capital in the amount of PLN 57,750.00, (hereinafter referred to as the "Owner"), the owner of the website www.wellu.eu ("Website") places in its users great respect and attaches great importance to the respect of their rights, with particular in regard to the right of protection of privacy. Therefore, regarding the Users of the Website we collect a minimum amount of information to help us better understand their needs and constantly adapt the Website, its functionality and ergonomics to the constantly changing expectations. Among other things, for this purpose we collect and process necessary data, including the personal data of Users. In order to accurately explain the principles and mechanisms used for collecting and processing your data we have created this Privacy Policy.

The Owner of the Website collects personal information and other data not having such forms. The collection occurs, depending on the type of data, on the initiative of the User or automatically.

Using the Website in any way you, dear User, accept the principles contained in this Privacy Policy.

Data collected during registration:

In order to use some features of the Website, you will need to register. During registration we will ask you to provide you personal information and to provide data that does not have such a nature, but which are also included in this Policy.

Providing personal data and also consent for their processing is not mandatory (it is voluntary), but it is necessary for the Owner to provide certain services in the framework of the Website.

The personal data processed by the Owner acting as the administrator of personal data for the purposes and in the manner specified in the content of the statement of consent for the processing of personal data or in the content of the information in the appropriate terms and conditions. You have the right to access to your data and to modify them, and to other operations described in the Website's terms & conditions. In the above matter you should make you request to the Owner by writing to the Owner's registered office address also given in the statement.

Data collected automatically:

During your visit to the web pages, the Website automatically collects data concerning for your visit, i.e. your IP address, domain name, browser type, the type of operating system - these data do not allow to uniquely identify your person.

Data is collected when you contact us:

When you contact us for the purpose of conducting given operations (e.g. submitting a complaint) via the Website, phone or email, again we will require you to provide your personal information to verify your identity and the possibility to contact you. This applies to the same personal data that you, dear User, previously provided. Again, providing this data is not mandatory, but is necessary to perform operations or obtain information that interests you.

The use of data:

The personal information that you provided and to which processing you have consented to shall be processed only to the extent and purpose included in the given consent or for purposes permitted by law.

Data collected automatically can be used to analyse User behaviour on the Website or to collect demographic information about our Users.

The data collected in the course of correspondence between you and the Owner will only be used to make possible the correct, full and effective response to your inquiry.

In the event of a violation of the Website's Terms & Conditions connected with a violation of the law, and also and without such violation but on the basis of the other provisions, the Owner may disclose your data, including personal data, to judicial authorities in situations provided by law.

How we will contact you?

The Owner normally communicates with Users using the email addresses they provide. In cases where the Owner deems it appropriate or helpful, it may also contact Users by phone (including text messages) or in writing.

Cookies:

Cookies are short information that a given website saves on the disk of your computer in the form of text files, thanks to which we are able to calculate the popularity of the Website. We become familiar with you to learn what information you need and what you are looking for on our Website. We want to know which category you visit more often than others, so that we can become even more attractive and give better service in the future. You give us knowledge about in which direction we should develop, what are your requirements, what is missing and what you think should be included on the Website. Moreover, cookies are used by the Website to maintain the User's session (after logging in), thanks to which the User does not need to re-enter their login and password on every sub-page, for the creation of statistics, which help us understand how Users use the web pages, and allows improving their structure and content.

Therefore, using a given website, it is you who mainly decides on its future shape. Cookies do not in any way destroy or damage your computer's system, stored files or deliberately have an adverse affect on its performance or functionality. Identification is impersonal, anonymously and is data concerning only the manner and form of using the website.

The Website uses two main types of cookies: session cookies and persistent cookies. Session cookies are temporary files that are stored on the end device of the user until he logs off, leaves the website or turns off the software (web browser). Persistent cookies are stored on the end device of the user for the period specified in the parameters of the cookie files or until their removal by the user.

The Website uses the following types of cookies:

- a) necessary cookies, which enables the use of services available within the Website, such as authentication cookies used for services requiring authentication within the Website;
- b) cookies used to ensure safety, e.g. used to detect fraud in the authentication within the Website;
- c) performance cookies, allow collecting information on how the Website is used;

- d) functional cookies allow storing user-selected settings and personalised user interface, e.g. in terms of language or selected region in which the user resides, the font size, the appearance of the web page, etc.;
- e) advertising cookies allow providing users advertising content more adapted to their interests.

Cookies may be used and inserted in your end device also by advertisers and partners cooperating with the Owner.

The acceptance of Cookies is not mandatory to use the Website, and the Owner shall inform Users, clearly and distinctly on the web pages, about the purpose of storing and obtaining access to cookies as well as the possibility for the User to determine the conditions regarding the storage or access to cookies using the settings of the software installed in the device the User. We inform that the lack of acceptance of certain cookies will prevent the correct operation of the Website to the full extent.

You can consent to saving cookies on your device and to their use as described above by selecting the appropriate settings on the web browser that you use, i.e. the browser settings allow accepting cookies or respectively, no change in such settings already existing after the receipt of the above information, which means consent for the Owner to receive and use the cookies as described above.

In order to not receive cookies you should use the web browser options used to connect to the Website and select the option to automatically reject cookies. These settings usually also allow managing cookies in the remaining range.
